Big Horn County Reports Four (4) Newly-confirmed Cases of COVID-19***Another case from possible community spread***

HARDIN, MONTANA (July 19, 2020) – Big Horn County added four (4) confirmed positive cases of COVID-19 on Sunday. All are symptomatic. One (1) patient likely contracted the virus through community spread and three (3) were contacts of previously-confirmed cases.

Recoveries in Big Horn County remain at 70. Five (5) persons are deceased. Of the 72 active cases, 66 patients are quarantining and recovering at home, and six (6) patients remain hospitalized.

Big Horn County wants to remind all residents of the County to wear a mask and social distance when outside of their homes and in public. Masks are required when engaged in indoor activities, such as

shopping. Masks are not necessary in the event that residents are outdoors and unlikely to come within six (6) feet of other people, such as while taking advantage of our beautiful county, to work, recreate, or exercise.

Tracking down contacts to a positive case (contact tracing) is one of the best tools public health can use to slow the spread of the virus. If you believe you were in the presence of a recently confirmed COVID-19 case for more than five (5) minutes, please call public health so that a nurse may interview you and determine what level of exposure you have:
