**Big Horn County Reports 19 Additional  
Newly-confirmed Cases of COVID-19  
35 total cases added on Tuesday, July 28, 2020**

**HARDIN, MONTANA** (July 29, 2020) – Big Horn County added 19 additional cases of COVID-19 on Tuesday for a total of 35 cases on the day. Of the newly-confirmed cases, 18 patients were tested as a result of contact with previously-confirmed positive patients and were asymptomatic when tested. One (1) patient presented with symptoms and likely contracted the virus through community spread, as there are no known contacts with previous cases at this time.

Recoveries in Big Horn County remained at 110. Five (5) persons are deceased. Of the 141 active cases, 133 patients are quarantining and recovering at home, and eight (8) patients are hospitalized.

Big Horn County wants to remind all residents of the County to wear a mask and social distance when outside of their homes and in public. Masks are required when engaged in indoor activities, such as shopping. Masks are not necessary in the event that residents are outdoors and unlikely to come within six (6) feet of other people, such as while taking advantage of our beautiful county, to work, recreate, or exercise.
