Big Horn County Reports Three (3) Newly-confirmed Cases of COVID-19***Five (5) hospitalized***

HARDIN, MONTANA (July 14, 2020) – Big Horn County added three (3) confirmed positive cases of COVID-19 on Tuesday. One (1) was found through contact tracing and was asymptomatic. One (1) was tested at a drive-through testing, and one (1) is likely community spread. Both were symptomatic.

Recoveries in Big Horn County rose to a total of 70, with one (1) additional patient recovered. Five (5) persons are deceased. Of the 54 active cases, 49 patients are quarantining and recovering at home, and five (5) patients are hospitalized.

Big Horn County wants to remind all residents of the County to wear a mask and social distance when outside of their homes and in public. Masks are required when engaged in indoor activities, such as shopping. Masks are not necessary in the event that residents are outdoors and unlikely to come within six (6) feet of other people, such as while taking advantage of our beautiful county, to work, recreate, or exercise.
